The Executive Council met on Wednesday, June 30, 2021 to review and vote on 179 warrant/agenda items and to approve Civil Commissions, Nominations and Confirmations, as well as Department of Military Affairs and Veterans Services Nominations, Confirmations and Appointments. The Executive Council will vote on the nominees at the next meeting of the Council on Wednesday, July 14, 2021. Additionally, 64 Informational Items, Pursuant to RSA 21-P:43, RSA 4:45, RSA 4:47 and Executive Order 2020-04 as extended by Executive Orders 2020-05, 2020-08, 2020-09, 2020-10, 2020-14, 2020-15, 2020-16, 2020-17, 2020-18, 2020-20, 2020-21, 2020-23, 2020-24, and 2020-25 were included on the agenda.

DIVISION OF MEDICAID SERVICES: At the last meeting of the Fiscal Year, the Executive Council was charged with reviewing and voting on 179 warrants/contracts - including the New Hampshire Medicaid Care contract (Amendment 6) and the Medicaid Management Information System. Over the past few months, I have been researching, assessing and receiving briefings on the status - and future projections - on the 6th Amendment to New Hampshire's Medicaid contract, with the three Managed Care Organizations, fulfilling the contract. New Hampshire's Medicaid Enrollment June 2021 was approximately 220,000, an increase of 25% since March of 2020, and is expected to return to pre-COVID levels of 180,000 over the next few months.

New Hampshire Medicaid cost trends have been competitive. Cost per capita has decreased, even with a 6.2 provider increase going into effect. Constituents have contacted me regarding capitation rate setting. Hampshire's capitation rates must comply with the Center for Medicaid Services guidelines, which require actuarially sound capitation rates which are reasonable, appropriate, and attainable, while ensuring the program serves eligible residents for the contract period. The State of New Hampshire has done an exemplary job securing waivers from CMS. On January 22, 2021, I voted in support of a waiver request, in response to deferred care and an enrollment reduction during the pandemic, which resulted in a Capitation reduction of 3%, which resulted in shared costs reductions of \$128,374,314.00

During meetings with managed care organizations, I called for answers and solutions to the increase in pediatric psychiatric boarding, the dearth of intensive outpatient programs in New Hampshire and the reduction of certain staff and services in the amended contract. Furthermore, I analyzed contractor fulfillment and performance by assessing rates for provider claim denials and suspensions and reviewing NH Medicaid Prioritized Quality Improvement reports - which measured Adolescent Health Prevention, Women's Health Prevention, Adult Mental Health Treatment, Children's Mental Health Treatment, Substance Use Disorder Treatment to measures of appropriate care.

Medicaid Management Information System (MMIS) is broken down into two components: Fiscal Agent and Operations and Quality Assurance.. Conduent State Healthcare LLC, (Fiscal/Operations) will sustain provider services, Claims Processing, System Integration (6 DHHS systems), Call Center, Federal Reporting and Training. Medicaid requires a third party vendor to monitor quality assurance compliance, which NTT will continue to fulfill. The state's current MMIS is using legacy software and hardware purchased in 2007 and as a result of not funding deferred maintenance, the system is at risk of losing certification, which would result in loss of federal match of \$6.6 million. Additionally, failure to maintain interoperability (patient access) after July 1, 2021 would result in a \$1 million annual fine, along with the loss of other federal match funds.

The New Hampshire Department of Information Technology and the DHHS recommended a strategic reprocuerment approach for the state's next MMIS, which will be implemented at the conclusion of the amended five year contract contract (June 30, 2026) with these vendors. The State anticipates a modular approach, which would integrate 14 DHHS systems vs the original six. Sustaining and upgrading New Hampshiure's MMIS is essential to protecting sensitive health records from a potential data breach. In 2020, more than 560 healthcare organizations and facilities in the United States had data breaches - including state Medicaid programs in Ohio, Texas, South Carolina.
