I was honored to host the Executive Council meeting on Wednesday, August 18, 2021, at the Salem High School Seifert Performing Arts Center. At the meeting, I highlighted the accomplishments of several residents/organizations that have contributed to the betterment of New Hampshire. Honorees included: Martha Stone, Executive Director at Cross Roads House located in Portsmouth; Pease Greeters based at Portsmouth International Airport at Pease; former New Hampshire House Speaker, Donna Sytek of Salem; members of the Salem and Londonderry Fire Departments for their work with vaccine distributions; and NAMI New Hampshire.

Earlier in the morning at the Executive Council Breakfast Meeting, the Executive Director for the Boys and Girls Club of Salem spoke - along with Joe Farro - developer of Salem's Tuscan Village and Donna Morris, Executive Director at the Greater Salem Chamber of Commerce.

During the Summer, the Executive Council met in each Councilor's District. This is a unique opportunity for the public to witness the Executive Branch of New Hampshire government in action, as the Governor and Executive Council discuss and debate the affairs of the state.





Governor's Advisory Council on Intermodal Transportation (GACIT) - Public hearings have begun for GACIT's Ten Year Transportation Improvement Plan (2023-2032), with the goal of informing New Hampshire residents and stakeholders of proposed projects and to receive public input on statewide transportation projects. The first District 3 Hearing will be held on Monday, September 27th at 7:00 pm at Epping Town Hall, 157 Main Street. I encourage all to attend. The Executive Council met on Wednesday, August 18, 2021 at the Salem High School Performing Arts Center to review and vote on 127 warrant/agenda items and to approve Civil Commissions, Nominations and Confirmations, as well as Department of Military Affairs and Veterans Services Nominations, Confirmations and Appointments. The Executive Council will vote on the nominees at the next meeting of the Council on Wednesday, September 1, 2021.

DEPARTMENT OF TRANSPORTATION

- Authorized the Bureau of Right of Way to sell 3.8 +/- acres of State-owned land located at 45 Westville Road in the **Town of Plaistow**, to Strategic Real Estate Management LLC, for the amount of \$525,000 plus an administrative fee of \$1,100. Originally purchased with 80% Federal, 20% Highway Funds.
- Authorized the Bureau of Aeronautics to accept and expend a grant in the amount of \$30,000 awarded under the American Rescue Plan Act and administered via the Federal Aviation Administration, to cover 10 of the FAA Airport Improvement Program projects at the **Portsmouth International Airport at Pease**. Effective upon G&C approval through June 30, 2023. (2) Further authorize to **retroactively** award a grant to the Pease Development Authority, to reconstruct a service road on the west side of the airfield, from the North Apron to Gate 1 (Grafton Drive) at the Portsmouth International Airport at Pease, Portsmouth, NH, in the amount of \$300,000. Effective upon G&C approval through June 17, 2025. **100% Federal Funds.**

COMMUNITY DEVELOPMENT FINANCE AUTHORITY

- Authorized, under the Community Development Block Grant program, to award a grant to the **County of Rockingham**, **Brentwood**, **NH**, in the amount of \$355,850 to support its water system improvement project at the **Rock Rimmon Cooperative**, **Danville**, **NH**. Effective August 18, 2021, through December 30, 2023. **100% Federal Funds**.
- #50 Authorized, under the Community Development Block Grant program, to award a grant to the **County of Rockingham, Brentwood, NH, in the amount of \$427,750 to support the multiple home rehabilitation project at homes owned by One Sky Inc., in the Towns of Newmarket, Exeter, Epping and North Hampton, NH. Effective August 18, 2021 through December 30, 2023. 100% Federal Funds.**

NEW HAMPSHIRE LIQUOR COMMISSION

Authorized the Indirect Cost Allocation Plan for State Fiscal Year 2021 due to the closing of **store #20**, **Derry**, **NH.** Contingent upon Fiscal Committee approval on August 20, 2021.

DEPARTMENT OF ENVIRONMENTAL SERVICES

- #89 Authorized to enter into a grant agreement with **Cora Beth Fisheries LLC, South Hampton, NH**, totaling \$40,000 for partial funding of a commercial fishing boat marine engine replacement project. Effective upon G&C approval through December 31, 2021. **62.5% Federal, 37.5% VW Settlement Funds.**
- #91 Authorized to execute a contract with **Preservation Company**, **Kensington**, **NH**, to provide on-call architectural historian services for projects related to the reconstruction, rehabilitation and/or removal of certain dams owned by the State of NH, in the amount of \$70,000. Effective upon G&C approval through December 31, 2023. **100% Capital (General) Funds.**
