

# **Voter Registration**

The Registrar of Voters will be in session Monday through Friday, from 8:00 a.m. to 5:00 p.m. for additions and corrections to the checklist. **Wednesday, August 31, 2022, is the last day that the City Clerk may accept voter registration applications or make name or address corrections to the checklist prior to the State Primary Election on September 13, 2022.** New voters may also register at the polls on Election Day. (RSA 654:27, 654:28, 654:7-a, 654:32).

The Board of Registrars will meet on Thursday, September 1, 2022, at 10:30 a.m. in Conference Room 208, City Hall, 229 Main Street, Nashua, to certify the checklist to be used for the September 13, 2022 State Primary Election, and to conduct such other business as may come before it.

May 31, 2022 was the last day a registered voter could change party affiliation prior to the September 13, 2022 State Primary Election. The polls will be open from 6:00 a.m. to 8:00 p.m. If you are not sure on your party affiliation, you may visit the City Clerk's Office to view the posted checklist or visit the State of New Hampshire Voter Information Look-up website at <a href="http://app.sos.nh.gov">http://app.sos.nh.gov</a>.

A person must meet the following to register and vote in New Hampshire:

- 18 years of age or older on election day;
- o A United States citizen; and
- Domiciled in the town or ward where the person seeks to vote.

If you do not have identifying documentation to meet any of the above criteria, an affidavit can be used to prove identity, age, citizenship, or domicile. Please visit

## Military or Oversees Citizen Registration:

If you are a member of the military you can obtain from your commanding officer a Standard Form 76 (red and white form), Federal Post Card Application - Registration and Absentee Ballot Request. If you are an oversees citizen or if your commanding officer does not have the form you can print out the online version of the Federal Post Card Application

All applications must be approved by the Board of Registrars before being added to the checklist.

# **Elections**

The Office of the City Clerk conducts and preserves the integrity of all local, state and national elections. The State Primary Election will be conducted on September 13, 2022, followed by the State General Election on November 8, 2022.

**Absentee Ballot applications** for the upcoming elections can be printed using the link below. You may mail, e-mail, fax, or hand deliver your completed application to the Office of the City Clerk.

#### PUBLIC HEALTH CONSIDERATIONS AND ABSENTEE VOTING

A person can register and vote by absentee if, based on their own health circumstances, medical authorities advise them to avoid going out in public. This applies to:

- 1. voters with symptoms of a communicable disease or illness;
- voters who, due to their own health circumstances, limit public exposure in their day-to-day life as a preventative measure.

These two types of voters can reasonably conclude that a "physical disability" exists within the meaning of RSA 654:16 and 654:17, absentee registration and RSA 657:1, absentee voting.
